Traditional Philately Commission Meeting in Seoul, South Korea on Sunday 10 August 2014

Agenda point 1.

The new chairman Lars Peter Svendsen welcomed all participants at the meeting and was happy so seeing so many people attending the meeting. A special welcome was given to the two F.I.P. Board members present, Bernard Beston and Peter McCann.

The chairman announced he had appointed Patricia Stilwell-Walker, USA as secretary of the commission until the next F.I.P. congress and vote to the bureau in 2016.

Agenda point 2.

Roll call showed 36 delegates and proxy voting privilege present.

Agenda point 3.

The minutes from Australia 2014 on 5 June 2013 was approved without comments.

The chairman presented all major events and achievements by the Traditional Philately Commission since the last congress in Jakarta 2012.

A Seminar and Workshop was held at BRASILIANA-2013 in November 2013

- Provided lists of FIP jurors accredited in the Traditional Class
- Discussion in the Bureau about use of Pre Philatelic material and Postal Stationeries in Traditional Philately (result presented in newsletters)
